

NOTICE TO EXHIBITORS

- * The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- * It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- * No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- * Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

DIRECTIONS:

From Interstate 64 - Take exit 119 - Hwy 150/Greenville/Paoli exit. Go 3.8 miles on Hwy 150. Turn right on Stiller Rd. Go 1.3 miles and turn right on Fertig Creek Rd. Go 1.5 miles. Cross straight over Scottsville Rd at the stop sign and you will be on Starlight Rd. Go about 1 mile and watch on right for a lake and stone mail box (7844) by asphalt drive. Do **not** take this entrance. Continue on a short distance and use the next drive on the right. This will take you back to the training building.

From New Albany - Take State Street (turns into Paoli Pike) on out toward Floyds Knobs. Turn right on Scottsville Rd. Go approximately 3 miles. Turn right on Starlight Rd. Go about 1 mile and watch on right for a lake and stone mail box (7844) by asphalt drive. Do **not** take this entrance. Continue on a short distance and use the next drive on the right. This will take you back to the training building.

PRIZES & AWARDS: Placement rosettes or ribbons will be awarded for 1st through 4th place for Qualifying and non-qualifying scores for all classes. Dogs with an NT (no time) are not eligible for any ribbons. Qualifying ribbons will be awarded to all dogs receiving a qualifying score, and Jr Handlers in Standard.

EXERCISE YOUR DOG RESPONSIBLY! PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE AND HOTELS! ALL DOGS MUST BE ON LEASH EXCEPT WHEN IN THE RING OR WARM UP AREA. THERE IS A LEASH LAW IN THE TRIAL SITE'S STATE.

OBSTACLES: The following obstacles may be used. Obstacle specifications shall meet the current CPE obstacle requirements

Aframe – 9' sides, rubber granules, slats	Dog Walk – 12' planks, rubber granules, slats
Teeter – 12' plank, rubber granules, slatless	Weave poles – 24" poles - center to center
Jumps: Bar, Spread, Panel	Open Tunnels

Crating: Due to the pandemic, we are encouraging people to crate from your car. You are also more than welcome to bring a pop-up tent to set up in the large grassy area to the left of the facility. There is plenty of room to crate outside. We will have limited crating space inside, some of which will be reserved, in order to follow the guidelines set in place for social distancing. Please bring CLEAN ground cover to place under your crate(s) and chair(s).

Measuring: Please note that no official measuring will take place at the trial. You can find the jump height table in the rule book on page 13. Please ensure that you refer to this and enter your dog in the correct jump height. Ensure that you indicate on the entry form which category as well as jump height that you are entering.

Additional Pandemic Precautions: Please ensure that you review CPE's guidelines regarding the pandemic, effective May 11, 2020 PRIOR to entering the trial. We WILL be following these guidelines and will require that individuals wear masks while in the ring and **STRONGLY ENCOURAGE MASK WEARING WHILE IN THE BUILDING AT ALL.**

Running order: tall (24") to small (4") each day.

Refunds: Bitches in season and injured dogs should not compete in agility trials. Refund of entry fees for injured dogs or bitches entered in the trial that come in season after the closing date of this trial may be obtained by sending a veterinarian's certificate to the trial secretary before the start date of the trial. Entry fees will be refunded less \$5.00 per run. Unfortunately, we are only able to provide these refunds for bitches in season and injured dogs. We are not able to provide refunds due to other reasons for which one must withdraw after the closing date unless there is a waiting list for the trial.

Please double check the total amount due before writing your check. **Any over-payments in the amount of \$10 or less will NOT be refunded.**

Volunteers: Trials run more smoothly with your help! We are looking for volunteers to help at our trial. Along with the final confirmation letter, links will be sent to sign up for spots to work. Please look for the links and sign up to help in any way that you can. 😊

CPE trial rules – shortened version: see the online rulebook at www.k9cpe.com for registration info, “Registering with CPE” and further info on height categories and rules.

Jump Heights – no dog will jump lower than 4”

P-Card = Permanent Card: the lowest allowable Regular height a dog may jump in CPE.

General CPE rules for entries/show site:

- Dogs must be at least 15 months or older the first day of the trial
- Blind (both eyes), lame, in season or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site.
- Dogs must be registered with CPE prior to the closing date of the trial, or by the trial date for Day Of Show entries. Registration forms are on the Forms page: www.k9cpe.com. Forms MUST be mailed to CPE and are processed 2-3 times per week. CPE ID numbers are emailed to legible email addresses. Registrations can only be processed from mailed forms.
- Dogs must be able to be measured at their first show. If a dog cannot be measured, the dog cannot run and no refund will be issued. Dogs within ½” of a jump height require at least one more measurement. When dogs reach their second birthday, a measurement is required. All dogs must be measured at their first trial regardless of jump height.
- Only CPE Judges can measure dogs.
- Electronic shock collars are not allowed at ANY CPE trial – training or bark.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. A warm-up jump shall be provided for all entered dogs. No relieving of dogs in the warm-up area.

Dogs in the ring, leashes, exiting the ring

- Dogs shall run without anything attached to its body. This is for the safety of the dog. This includes no: collars, stitches, wraps or any other item. The only exception is a small barrette or rubber band to keep hair out of a dog’s eyes.
- Leashes may not have anything (other than name/license tags) attached to them when used in the ring.
- Dogs may enter the ring on a collar, quick release harness or head halti/leader. If prong collars are allowed per the show site, they may *not* be used to take a dog into the ring.
- Handlers may not carry their leash with them on the course – if done so, an NT will result. Exception: Handicapped handlers that have a mobility

problem in picking up the leash at the finish may put their leash in their pocket – the leash must be out of sight.

- Dogs must be under the handler’s control when leaving the ring or the judge may enter the run as No Time - NT.

Declared Training In the Ring

We, Flying Feet Agility will offer Declared training in the ring. The handler has the option if they want to use a toy or training aid at any time during their run, the handler must approach the Judge during Walkthrough or previously in that trial day for the Judge to approve the toy or training aid for use on the course.

- Handler must alert the Judge upon entry to the ring that the dog will be TIR. Handler is then allowed to have a reasonably sized silent toy/aid with them for use once their run has started (this toy must be approved by the Judge of record PRIOR to the start of the class to determine its eligibility, absolutely no food/scents/audible devices). The toy is NOT allowed to be used in either gate chute or prior to the previous dog leaving the ring.

See the online rulebook or current member letter for additional rules.

The following items *are* considered training in the ring (see Fix and Go):

- Violating the 4 paw safety rule (directing the dog back onto the contact)
- Start line stay – leaving the dog and going back again to reposition the dog after the handler passes the plane of the first obstacle (before the handler leaves the dog, repositioning or repeated commands can be a delay of start)
- Putting the dog back on the table in the point games

While running on course

- The handler will direct the dog through the course without a collar or lead.
- Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10’ feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.
- The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair, etc., to enable their progression around the course.

The handler may use any verbal or visual commands to direct the dog through the course. The Judge may assess a 5 fault penalty to elimination for any command that is not given in a sportsmanlike manner. Faults can be but are not limited to: foul or abusive language, display of anger, extreme frustration or excessive harshness. If the fault is severe enough, the Judge has the right to excuse the exhibitor from the ring and / or the remainder of the trial. If excused from the trial, a report would be filed with CPE. See Faults, Eliminations and Excusals in the rulebook.

This also includes if there was a correction to a scribe sheet – the handler must verify that the results were corrected as well.
